Clinical Chair's Report

1.0 The New Normal

I have been supporting the work with hospital consultants in secondary care to provide more routine services for patients waiting during the lockdown. This has led to the development of local services in GP practices for cardiology. This is a model we wish to develop further.

2.0 Media Interviews

I have been interviewed over Zoom by ITN to explain the changes to general practice. The campaign on the NHS is open for business has continued and part of that I did as a video statement and that is being used with the campaign materials around Harrogate.

3.0 Humber Coast and Vale ICS

I am now participating in the Chairs Conference call that is part of the CCG's engagement within the ICS. The first meeting the ICS Partnership Operating Arrangements of the ICS was presented and discussed. I am hoping there will be a version to share with the Governing Body shortly.

4.0 Adoption and Fostering Medicals

I have been working with North Yorkshire County Council and City of York Children Safeguarding Teams and the Designated Doctors for Safeguarding on both patches. The need for medicals to be performed on prospective parents continues for safe placement of children. I have produced a video consultation medical that has been agreed by all parties and the LMC. This has also been shared with CoramBAAF a national adoption agency and they have accepted it as their model too.

5.0 Committee Chairs Development

All four Committee Chairs have participated in a workshop. This is to ensure consistency of approach across all of the statutory committees. Our thanks to the Governance Team for delivering the session
